GSCCC is a public/private partnership developed to promote the use of alternative fuels, and alternative fuel vehicles in New Hampshire to help reduce our dependence on foreign oil and improve air quality. GSCCC was formally designated as a Clean Cities Coalition by the US Department of Energy in May 2002 and currently has forty stakeholders representing private businesses, government agencies, alternative fuel providers, vehicle manufacturers, and others. GSCCC welcomes stakeholders, guests, and other interested parties to attend our stakeholder meetings.

Topics to be discussed at the January meeting include:

- ❖ Request for Proposals for the 2003 State Energy Program grants for AFV projects. Applications for this year's grant will be due in March. We will discuss what is needed in the grant application and what resources are available to assist you in your project planning.
- ❖ Ford and GM purchase incentives. Both companies are offering incentives for AFV purchases in 2003. An overview of both incentive programs will be covered.
- ❖ Availability of rebate money for AFVs. Some stakeholders may be eligible for a \$2,000 rebate for light duty AFVs purchased before May 31, 2003.
- ❖ Project Updates.

**Directions to Dept. of Environmental Services, 6 Hazen Drive, Concord:**  
From I-93: Take Exit 14. From northbound exit turn right, southbound turn left. Stay on Loudon Rd to the light at the top of the hill. Turn left onto Hazen Drive. DES is the building with all the stacks on the roof.

**From the Seacoast: Take Rte 4 to Rte 393. Exit at East Side Drive and turn left onto East Side Drive. At the second light turn right onto Hazen Drive. DES is just after the Dept. of Safety.**

**Parking is limited at DES due to construction. Please arrive early to allow time to find a spot.**
