V. EPA's SmartWay Transport Partnership - Lucy Edmondson - EPA Region 1

In 2004 EPA launched the SmartWay Transport Partnership as a collaborative effort between EPA and the freight industry to reduce energy consumption and greenhouse gas emissions from the freight transportation sector. The Partnership creates market-based incentives that challenge companies shipping products, and the truck and rail companies delivering these products, to improve their environmental
